
## Still No Room for Babies:

## Child Care Staffing Crisis Impacts Supply of Infant-Toddler Child Care

March 2023

Having access to a robust supply of high-quality licensed child care near their home or workplace is an essential support for working parents. Licensed child care programs not only offer parents a safe and reliable child care option while they work, but they can also be a valuable source of early education during the critically important first three years, laying the foundation for healthy development and success in school and life. Statewide, more than 207,000 children under age three live in families where both parents work, meaning they will be in need of some form of child care.<sup>1</sup>

## Recommendations to address the shortage of high-quality infant-toddler child care

- O Support an increase of CCDBG by \$4.3 billion in FY24—for a total discretionary funding level of \$12.4 billion.
- O Support an increase of \$17.47 billion for Head Start in FY 2024.
- O Support the Child Care and Working Families Act and funding that will provide basic grants, similar to Stabilization grants to support child care programs that have fewer children whose families are eligible for child care assistance but are struggling to meet the true cost of care without unduly burdening parents with higher tuition rates.
