




Unlocking Potential

Goal 2: By 2023, 9,867 more families with infants and toddlers from low-income households will have access to evidence-based home visiting.

- 1. Increase service capacity and program completion rates within the current system of evidence -based home visitation.
- 2. Expand the capacity of the current evidence- based programs to provide intensive home visiting supports to additional families.
- 3. Reframe and develop home visiting as inclusive of all families who want to participate.











Home Visiting In New Jersey

Goals:

- Reduce disparities in maternal, infant and early childhood health outcomes;
- Increase positive parenting;
- Prevent child abuse and neglect;
- Improve family economic self-sufficiency; and
- Promote early childhood development and school readiness.











Home Visiting In New Jersey



- 65 community-based programs proving home visiting services serving approximately 7,000 per year
- 3 evidence-based models serving all 21 NJ counties:
 Healthy Families New Jersey
 Nurse Family Partnership
 - **Parents As Teachers**
- New Universal Home Visiting Program (in planning stages)

| NFP | Registered Nurse | First-time pregnant women prior to 29 weeks gestation | NFP families are encouraged to participate until their child is 2 years old | NFP nurses provide health education and support to improve the health, well-being and self-sufficiency of the family, conduct clinical assessments, and work to ensure that families have access to other available services and supports, as needed. | |
| PAT | Certified Parent Educator | Anytime during pregnancy and up until the child is age 3 | The program serves families throughout pregnancy and up until their child completes kindergarten | The program is an early childhood parent education, family support and school readiness program designed to enhance child health, growth and development, and school achievement as appropriate | |
| Family Connects | Registered Nurse | After birth of child | 1-3 visits for families welcoming a newborn into their home | Nurses conduct a clinical assessment on the infant and birth parent, address any social needs of the household and connect families to appropriate resources. | • Universal |

Central Intake System – Connecting NJ

- Locally Driven Each county has a local lead coordinating agency (CI Hub)
- Single Point of Entry easy access for information, eligibility, referral & service links
- Reach Families Earlier beginning in pregnancy / Prenatal Risk Assessment (PRA)
